### **Explanation of Designations**

#### **Chartered Financial Analyst (CFA<sup>®</sup>) charter**

The Chartered Financial Analyst (CFA) charter is a globally respected, graduate-level investment credential established in 1962 and awarded by CFA Institute — the largest global association of investment professionals. There are currently more than 138,000 CFA charterholders working in 134 countries. To earn the CFA charter, candidates must: 1) pass three sequential, six-hour examinations; 2) have at least four years of qualified professional investment experience; 3) join CFA Institute as members; and 4) commit to abide by, and annually reaffirm, their adherence to the CFA Institute Code of Ethics and Standards of Professional Conduct.

#### **CERTIFIED FINANCIAL PLANNER<sup>™</sup> (CFP<sup>®</sup>) designation**

The Certified Financial Planner<sup>™</sup> (CFP<sup>®</sup>) designation is conferred by the Certified Financial Planner Board of Standards, Inc. Candidates must have a bachelor's degree (or higher) from an accredited college or university, three years of full-time personal financial planning experience and complete a course of study in financial planning topics. A candidate may be exempt from the course of study requirement if he or she holds a CPA, ChFC, CLU, CFA, PhD in business or economics, Doctor of Business Administration, or attorney's license. All candidates must successfully complete the CFP Certification Examination. CFP<sup>®</sup> practitioners are subject to the CFP Board's ethical standards.

#### **Enrolled Agent (EA) credential**

An enrolled agent is a person who has earned the privilege of representing taxpayers before the Internal

Revenue Service by either passing a three-part comprehensive IRS test covering individual and business tax returns, or through experience as a former IRS employee. Enrolled agent status is the highest credential the IRS awards. Individuals who obtain this elite status must adhere to ethical standards and complete 72 hours of continuing education courses every three years.

Enrolled agents, like attorneys and certified public accountants (CPAs), have unlimited practice rights. This means they are unrestricted as to which taxpayers they can represent, what types of tax matters they can handle, and which IRS offices they can represent clients before. Learn more about enrolled agents in Treasury Department Circular 230.

Christopher M. Gething Jr. is employed by Intuit as a credentialed tax expert. In this capacity, he provides tax advice to and prepares tax returns for Intuit customers during tax season. He spends approximately 20% of his time on this activity on an annual basis. Christopher M. Gething Jr. owns and operates Atherean Value Investors, LLC, which serves as the general partner for Atherean Value Fund, LP. Christopher M. Gething Jr. also owns and operates Atherean Enterprises, LLC, of which he is the managing member, sole employee, and sole member. He spends approximately 10% of his time on this business activity. Atherean Enterprises, LLC provides tax preparation and planning and consulting and rideshare and carshare services.

### **Item 5: Additional Compensation**

Christopher M. Gething Jr. receives income from Atherean Asset Management, LLC. He does not receive any additional compensation from Atherean Asset Management, LLC or any other client or business partner of AAM other than employment income from Intuit, and incomes from Atherean Enterprises LLC and Atherean Value Investors, LLC as described in Item 4.
