

FACTS**WHAT DOES Atherean Asset Management LLC DO WITH YOUR PERSONAL INFORMATION?****Why?**

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and assets
- risk tolerance and investment experience
- retirement assets and income

When you are *no longer* our customer, we continue to share your information as described in this notice.

How?

All financial companies need to share **customers'** personal information to run their everyday business. In the section below, we list the reasons financial companies can share their **customers'** personal information; the reasons Atherean Asset Management LLC chooses to share; and whether you can limit this sharing.

How does **Atherean Asset Management LLC** protect my personal information?

We collect your personal information, for example, when you

- Open an account or enter into investment advisory contract
- Tell us about your investment or retirement portfolio or seek advice about your investments
- provide employment information or give us your income information

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *Our affiliates include Atherean Value Fund, LP, Atherean Value Investors, LLC, and Atherean Enterprises LLC*

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *Atherean Asset Management LLC does not share with non-affiliates so that they can market to you*

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *Atherean Asset Management LLC does not jointly market*
